



Dr. Sam Shafiishuna Nujoma: Visionary Leadership for Namibia's Energy Future

As a natural resources law and policy expert, I have long been inspired by the leadership of Dr. Sam Nujoma, Namibia's Founding President and Father of the Nation. His pivotal role in the country's journey toward independence and sustainable prosperity laid the groundwork for Namibia's energy security and its emergence as a key energy player in Africa.

Building a Self-Reliant and Prosperous Namibia

Dr. Nujoma believed Namibia's mineral and energy wealth should benefit all Namibians. His commitment to and championing of education, infrastructure, sustainable development and policy laid the foundation for the country's energy future, ensuring long-term prosperity and growth. His principles of self-reliance and inclusivity continue to guide Namibia's goal of becoming an energy hub in Africa.

Dr. Nujoma understood that robust infrastructure was essential for energy security. He championed transformative projects like the Cape Fria port and a nationwide railway system, reducing dependency on external systems and facilitating the efficient movement of resources. These initiatives set Namibia on its path to becoming a regional energy hub.

Promoting Education and Capacity Building

Dr. Nujoma underscored the vital role of education in developing a skilled workforce for Namibia's energy sector. In 1999, 15 Namibian students, including myself, were awarded the Pacem in Terris Scholarship to study in the United States at La Roche College. During this occasion, Dr. Nujoma was honored with an Honorary Doctor of Public Service from La Roche College (now La Roche University), where he delivered this impactful speech:

"Namibia is a small country, but with a fair endowment of the world's natural resources. But we cannot, on our own, afford to establish the needed diversity of institutions of learning to be able to enhance our human resource capacity rapidly. As such, international solidarity is crucial. This is why we greatly value international cooperation in the field of education and training." Through initiatives like this scholarship, Dr. Nujoma ensured that young Namibians received the education and training needed to develop the country's energy resources.

Dedication to Beneficiation and Value Addition

Dr. Nujoma believed in adding value to Namibia's resources locally, creating jobs and driving industrial growth. His vision continues to shape Namibia's approach to sustainable economic growth, transforming it from a raw material exporter to an industrial leader in Africa.

Carrying Forward the Vision

I experienced Dr. Nujoma's commitment firsthand in 2012 after hosting the first Namibia International Oil and Gas Conference, which later evolved into the Namibia International Energy Conference (NIEC). He personally requested an audience with me, during which he applauded the initiative and emphasized the importance of positioning Namibia's energy sector on the global stage. His words reminded me of the immense responsibility we all share in continuing his vision.

His early recognition of Namibia's potential, his advocacy for human capital development, and his push for collaboration laid the foundation for today's energy leaders. His decision to study geology later in life continues to inspire many of us shaping Namibia's energy landscape.

The leadership team will focus on enhancing industry collaboration, strengthening local content policies, and refining regulatory frameworks to support the sector's sustainable growth. NAMPOA, which represents eleven major petroleum operators, plays a key role in advancing investment and workforce development in Namibia.

This collaboration reflects the two organizations' dedication to providing high-quality technical training for Namibia's youth, ensuring they gain the practical skills and expertise needed to excel in the oil and gas sector. By nurturing local talent and offering clear pathways to advanced specializations, PETROFUND and Chevron aim to strengthen the country's energy workforce, drive sustainable industry growth, and create long-term career opportunities for young Namibians.







Exploration in Motion: Key Developments

Shell: Discovered hydrocarbons in PEL 39 but encountered geological challenges, including high gas content. Despite a \$400 million write-down, Shell remains invested in unlocking the basin's potential.

Chevron: Drilled the Kapana 1-X well in PEL 90, which did not yield commercial reserves. However, the data gathered will guide ongoing exploration and future drilling strategies.

Rhino Resources: Recently announced a hydrocarbon discovery at the Sagittarius-1X well in Block 2914. This significant find highlights the presence of an active petroleum system, and further drilling at Capricornus-1X is already underway.

Galp's fifth well, Mopane-3X, in Namibia's Orange Basin under Petroleum License 83, has yielded another oil and gas discovery. The well encountered light oil and gas condensate in key targets, with high-quality reservoirs at 1,200m depth. Partners Custos Energy and NAMCOR see strong multi-phase potential, with further exploration and 3D seismic surveys planned for Q1 2025.

What This Means for Namibia

A Natural Part of Exploration: Oil and gas discoveries require time, analysis, and investment to reach commercial production. Each step contributes valuable insights into Namibia's resource potential.

Momentum Remains Strong: Despite setbacks, companies continue to invest in Namibia's offshore sector, demonstrating confidence in long-term opportunities.

Expanding Possibilities: With promising finds like Rhino Resources' and Galp's recent discovery, Namibia is positioning itself as an emerging force in global energy.

As exploration advances, every well drilled adds to the knowledge and potential of Namibia's energy future. With persistence, investment, and collaboration, Namibia remains on a path toward unlocking a new era of energy opportunities.

Chevron Expands Offshore Exploration in Namibia

Chevron has acquired an 80% stake and operatorship in Petroleum Exploration License 82 (PEL 82) in Namibia's Walvis Basin, reinforcing its commitment to offshore exploration.

Strategic Move: PEL 82 covers blocks 2112B and 2212A, an area with extensive seismic data and previous oil shows.

Partnership: Chevron holds 80%, while Custos Energy and NAMCOR each retain 10%.

Exploration Potential: The Wingat-1 well previously confirmed a working petroleum system, and further studies will assess commercial viability.

This acquisition highlights continued industry confidence in Namibia's offshore potential, positioning the country as an emerging energy frontier.

Namibia's Offshore Exploration Gains Momentum

Namibia's offshore energy sector is experiencing a surge in exploration activity, with multiple drilling campaigns underway in 2025. Global energy companies are expanding their presence, reinforcing Namibia's potential as a major emerging energy player.

Key Drilling Activities

TotalEnergies:

Marula-1X Well (Block 2913B) – Drilling commenced in February, targeting deepwater Albian-aged sandstones.

Olympe Prospect (Block 2912) – Planned for later in 2025, focusing on a high-potential structural trap.

Impact Oil & Gas:

Tamboti-1X Well – Reached 6,450 meters and encountered 85 meters of net oil-bearing reservoir. Further analysis is underway to determine commercial viability.

Rhino Resources:

Sagittarius-1X Well (Block 2914A) – Drilled in December 2024 as part of a multi-well campaign. Results will provide insights into the hydrocarbon system in the Orange Basin.

BW Kudu:

Kharas Gas Appraisal Wells – Up to two wells planned to assess gas reserves northwest of the Kudu Formation. Drilling is expected in Q3 2025, with a field development plan submission anticipated in Q2.

These drilling efforts reflect growing confidence in Namibia's offshore potential, as companies refine geological models and assess commercial prospects. As new data emerges, Namibia continues its journey toward becoming a significant energy player in the global market.
